 A Total Army social / partnership with a diverse group of soldiers and spouses – On Feb. 19, MVD hosted its first Mississippi Engineer Unit Professional Development event in Vicksburg. The inaugural event brought together local Active, Reserve and National Guard military members and spouses to share unit capabilities and support efforts in the local Mississippi area. • The Inland Waterways Conference in St. Louis (opening comments by Rear Admiral Kevin Cook and myself) brought together government and industry leaders to discuss issues, challenges and opportunities related to the maritime industry on inland rivers. This helped demonstrate to industry and federal partners our commitment to the Inland Marine Transportation System and the uninterrupted commerce it delivers. This was a great opportunity to meet the people most interested in our Fair Landing bendway revetment and weir construction (completed Feb. 22, 40 days ahead of schedule).

• Gaining alignment with the civil works team, specifically on our MVD/Great Lakes and Ohio River Division GLMRIS (Great Lakes and Mississippi River Interbasin Study)/Brandon Road study. The GLMRIS Brandon Road Lock & Dam project offers a unique opportunity for inter-division collaboration for MVD project management within the programmatic oversight of LRD.

• Other upcoming 2015 key strategic engagements that the MVD-MRC team is working include our Washington, D.C., visits (Mar. 16-19) and the high water inspection trip. I look forward to engaging and working with our congressional leaders and stakeholders during these two important events.

Moving forward, we must continue to prepare for the future by focusing on people, technology, process and strategic engagement. Always remember that the strength of our Nation is our Army; the strength of our Army is our Soldiers and Civilians; the strength of our Soldiers and Civilians are our Families. ### Mississippi River Commission schedules high-water inspection trip

The Mississippi River Commission will conduct its annual high-water inspection trip on the Mississippi River March 23-27, 2015.

Four public meetings have been scheduled aboard the Motor Vessel MISSISSIPPI in selected towns along the river so commission members have the opportunity to meet with local partners, stakeholders and residents and hear their concerns, ideas and issues. The meeting places, dates and times are as follows:

• March 23 - 9:00 a.m., New Madrid, Mo. (City Front)

March 24 - 9:00 a.m., Memphis, Tenn. (Beal Street Landing)
March 25 - 1:00 p.m.,

Vicksburg, Miss. (City Front)
March 27 - 9:00 a.m., Baton Rouge, La. (City Dock above USS Kidd)

All meetings are open to the public. Anyone with an interest is invited to present their views and suggestions on matters affecting the water resources infrastructure needs in the valley, including flood control and the Mississippi River and Tributaries project, environmental issues, recreation, navigation and others.

The agenda for each public meeting will be as follows:

1. Summary report by president of the commission on national and regional issues affecting the U.S. Army Corps of Engineers and commission programs and projects on the Mississippi River and its tributaries.

2. District commander's overview for the commission on current project issues in the respective district area.

3. Presentations to the commission by local organizations and members of the public giving views or comments on any issue affecting the programs or projects of the commission and the Corps of Engineers.

The MRC, established in 1879, is composed of seven members, each nominated by the President of the United States and vetted by the Senate. Three of the organization's members are officers of the Corps of Engineers; one member is from the National Oceanic and Atmospheric Administration; and three members are civilians, two of whom are civil engineers.

General duties of the commission include recommendation of policy and work programs, the study of and reporting upon the necessity for modifications or additions to the flood control and navigation project, recommendation upon any matters authorized by law, and making semi-annual inspection trips. The duties of the commission include the entire length of the Mississippi River from its headwaters at Lake Itasca, Minn., to Head of Passes, La., where the Mississippi River empties into the Gulf of Mexico.

The purpose of the public meetings is to maintain a dialogue, an exchange of viewpoints and ideas flowing between the watershed interests, the public and the Corps. Presentations by the public are made orally, but a copy of the remarks should be presented to the commission for the official record and written response.

The public hearing

process is unique to the Mississippi River Commission and the U.S. Army Corps of Engineers. The benefits of hearing the issues and concerns first hand through the public hearing process are invaluable to the commission and the Corps. Also, the interaction with congressional, federal and state interests, local boards and non-government organizations and the public is crucial to the decision-making process for the nation's water resources.

Since 1879, the seven-member Presidentially appointed Mississippi River Commission has developed and matured plans for the general improvement of the Mississippi River from the Head of Passes to the Headwaters. The Mississippi River Commission brings critical engineering representation to the drainage basin, which impacts 41% of the United States and includes 1.25 million square miles, over 250 tributaries, 31 states and two Canadian provinces.


# MVD honors National Women's History Month

This month, the Mississippi Valley Division recognizes and appreciates the invaluable contributions of the women in our workforce. They are vital to the division's mission critical accomplishments. Women's History Month gives us an opportunity to understand the critical link between knowing about historical women and making a positive difference in today's world. Each generation needs to draw information and inspiration from the last.

For March 2015, the National Women's History Project has selected the theme "Weaving the Stories of Women's Lives." The theme presents the opportunity to weave women's stories individually and collectively into the essential fabric of our nation's history. This year marks the 35th anniversary of the Women's History Movement and the National Women's History Project.

National Women's History Month can be traced back to March 8, 1857, when women from New York City factories staged a protest over poor working conditions. International Women's Day was first observed in 1909, but it was not until 1981 that Congress passed legislation requesting the president to proclaim the week beginning March 7, 1982, as Women's History Week. Congress continued to pass joint resolutions declaring a Women's History Week every March until 1987. In that year, Congress passed a law designating March 1987 as Women's History Month based on a petition by the National Women's History Project. Since that time, every president has issued proclamations for Women's History Month.

We must remember the women who have made a difference in our history. Two notable examples are Susan B. Anthony and Madeleine K. Albright. Anthony considered women and men equal and spent her life working for equality while promoting temperance and the abolition of slavery. Anthony was a member of the Equal Rights Association and a founder of the National Woman Suffrage Association. In 1872, she was arrested and convicted for voting, but fought for women's equality until she died in 1906. Former Sec-



retary of State Madeleine K. Albright was nominated for the position by President Clinton and was sworn in on January 23, 1997. At that time, she became the first female Secretary of State and was the highest ranking woman in the history of the U.S. government. In addition, Albright had previously served as a representative to the United Nations and as a member of President Clinton's Cabinet and National Security Council.

To commemorate Women's History Month, a poster is being displayed in the lobby of the Mississippi Valley Division and additional information will be available for viewing on the iNET throughout March.

Randy Holder has joined MVD as acting MR&T environmental program manager for the Programs Directorate.

Randy Holder is a senior environmental specialist in the Evaluation Section of the Vicksburg District's Regulatory Branch. He has served as an environmental specialist since April 2009. He is responsible for evaluating and permitting actions for activities in waters of the United States under Section 404 of the Clean Water Act and Section 10 of the Rivers and Harbors Act of 1899. Randy reviews and evaluates complex, controversial and environmentally sensitive permit applications. He ensures that all federal laws, regulations, policies and guidance are implemented and adhered to during the evaluation process. He resolves administrative and technical differences between USACE, federal, state, local, tribal authorities and the general public. Randy is also responsible for drafting environmental assessments that

outline the potential impacts for each project that is evaluated.

In October of 2012, Randy became a senior environmental specialist and took on the additional duties of the chair for the Internal Review Team (IRT) for Mississippi Wetland and Stream Mitigation Banks. The IRT consists of representatives from the Environmental Protection Agency, Fish and Wildlife Service, Mississippi Department of Environmental Quality, Mississippi Department of Wildlife, Fisheries and Parks and the Department of Marine Resources.

Randy attended the University of Southern Mississippi graduating with a bachelor's degree. He is a member of The Association of State Wetland Managers and serves as an Operations representative on the Quality Management Team. Mr. Holder is the Regulatory contact for all operations and maintenance business information link issues. and is the evaluations section lead for all Vicksburg District Regulatory website related issues.
